RULES:

1. This show is sanctioned by the American Dairy Goat Association and their rules shall govern.
2. These shows are open to all exhibitors and shall consist of 2 Senior Doe and 4 Junior Doe shows on Saturday, September 17 and 2 Senior Doe shows on Sunday, September 18, 2011. The Senior doe and Junior doe shows are separately sanctioned.
3. Breeds sanctioned are Alpine, LaMancha, Nigerian Dwarf, Nubian, Oberhasli, Recorded Grade, Saanen and Toggenburg.

5. Sanctions have been applied for.
6. **ENTRY FEES** will be \$3.50 per animal, per show if postmarked by **September 10, 2011**. Animals entered after 9/10/11 will be charged \$4.50 per animal, per show. A 10% discount will be given for more than 10 animals entered by same exhibitor per show.
7. All fees must be paid prior to the start of the show.
8. **PEN FEES** will be \$2.50 per pen (pen size 5' x 5" or 6" x 8"). This fee must accompany the entries. Exhibitors must remove bedding to the aisle at end of show.
9. The original registration certificate is required for all animals 6 months and over. Stamped duplicates for animals under 6 months will be accepted. The date for computing age will be the show date. The registration certificate or stamped duplicate must be presented to the show secretary at check-in. No copies of the certificate or unstamped application, or phone calls will be accepted in lieu of the original certificate or a stamped duplicate application.
10. No health papers are required for Minnesota animals; however, any animal is subject to rejection for unhealthy conditions at the discretion of the show committee. We will follow the ADGA policy on abscesses, which does not allow showing an animal with an abscess that is balding or draining. A veterinarian will be at the show to check health papers and the animals. All out-of-state animals must be accompanied by an interstate health certificate/certificate of veterinary inspection. Michigan residents must have TB and Brucellosis tests. Scrapie herd identification must be presented at time of veterinary inspection in order to show.
11. Animals may arrive any time after 4.00 p.m. on Friday, September 16. Animals must be in place by 7:00 a.m. on Saturday, September 17 or 7:30 a.m. on Sunday, September 18, 2011.

12. There will be no pre-show milkout, however, over-distended udders are discouraged and may be cause for disqualification at the discretion of the judge(s).
13. As a courtesy to others, please show your permanent champions in the champion challenge class.
14. All exhibitors are requested, but not required to wear white shirts and white or black pants in the show ring.
15. All animals are entered at the owner's or designated exhibitor's risk. The club and fairgrounds will not be responsible for loss, damage, theft or accident to any person, animal or property.
16. All animals are to be properly collared, chained and under control at all times.
17. Judges will only give reasons on goats placing 1-6 in order to expedite the show.
18. A raffle will be held and any donations will be happily accepted and appreciated.
19. All exhibitors must furnish their own feed, bedding and equipment.
20. A barbecue will be held Saturday night on the grounds. Fee will be \$7.00 per adult, children under 10 free.
